## **Your Unlicensed Medicines**

## **WHAT IS THIS LEAFLET ABOUT?**

In the UK most medicines are 'licensed' but some are not. This leaflet explains why medicines are licensed and why some useful medicines do not have licences at all, a licence for your illness or for children in general.

You will have been given this leaflet by your doctor or pharmacist because the medicine prescribed is not 'licensed' or does not have a licence for your illness or for children in general. We want to reassure you that we have thought very carefully about the best medicine for you or your child.

## **WHY ARE MEDICINES "LICENSED"?**

The manufacturer of each medicine must ask the government for a 'Product Licence' if they want to sell their medicine in the UK. They must demonstrate that their medicine is effective for the illnesses to be treated, has been made to a high standard and does not have too many side effects or risks.

## **WHICH TYPES OF MEDICINES DO NOT HAVE A LICENCE?**

- Some liquid medicines for children
- Some medicines only used for rare illnesses.
- Some medicines that have not been through a full clinical trial

## **HOW DO I KNOW THE MEDICINES ARE SAFE AND WILL WORK?**

This medicine will have been recommended by an expert or your doctor will have read information that says it is the best one for you or your child.

If you or your child needs a special medicine your pharmacist will ensure a suitable preparation is available.

## **HOW WILL I KNOW IF A MEDICINE IS NOT LICENSED?**

Your doctor or pharmacist can tell you.

When you read the information leaflet you may notice the information doesn't refer to the specific illness you have or it may say it should not be used for children or your child's age.

Unlicensed medicines may be more difficult to obtain. Your pharmacist will inform you of this and ensure special arrangements are made to fulfill your prescription.

## **SHOULD I BE WORRIED ABOUT TAKING/GIVING THESE MEDICINES?**

Your pharmacist may have made a special information leaflet about the medicine or illness. Please ask.

Often there are support groups for particular illnesses or conditions. If you are a member seek advice from the group.

If you are not a member ask your doctor, pharmacist or nurse for more information.

## **IF I HAVE FURTHER QUESTIONS WHAT SHOULD I DO?**

Talk to the person who gave you this leaflet (usually your doctor or pharmacist).

## **INFECTION CONTROL REQUEST**

Preventing infections is a crucial part of our patients' care. To ensure that our standards remain high our staff have regular infection prevention and control training and their practice is monitored in the workplace. We ask patients and visitors to assist us in preventing infections by cleaning their hands at regular intervals and informing staff of areas within the hospital that appear soiled.

As a patient there may be times that you are unsure whether a staff member has cleaned their hands; if in doubt please ask the staff member and they will be only too happy to put your mind at ease by cleaning their hands so that you can see them.
